# ORDINANCE NO. 2016 – 023

# AN ORDINANCE ADOPTING HOURLY, WEEKLY AND MONTHLY PAY FOR EMPLOYEES AND ELECTED OFFICIALS OF THE TOWN OF SELLERSBURG, INDIANA FOR CALENDAR YEAR 2017.

**WHEREAS**, pursuant to Ind. Code § 36-5-2 *et seq.*, this Town Council of Sellersburg, Indiana (this "Council") is the town legislative body and the President of the town council is the town executive; and,

WHEREAS, this Council is charged with the responsibility of adopting a salary ordinance; and,

WHEREAS, the decision to establish salaries for the employees of the Town of Sellersburg, Indiana is a discretionary legislative decision that lies solely with this Council.

**NOW THEREFORE BE IT ORDAINED** by this Town Council of Sellersburg, Indiana the following salaries and respective funds from which to pay said salaries for the calendar year 2017:

- 1. See *Exhibit A* attached hereto for the comprehensive list of job titles for the Town of Sellersburg and the specified funds by which to pay each position.
- 2. Each department head shall send a list of current employees, their hire dates, and the expected job title each employee will hold as of January 1 per the list of job titles set forth in Exhibit A to the Clerk-Treasurer, this Council, and the Town Attorney.
- 3. This ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council.
