ORDINANCE NO. 2017 - OR - 001

AN ORDINANCE AMENDING FEES ESTABLISHED BY ORDINANCE NO. 96-657

WHEREAS, pursuant to Ind. Code § 36-5-2 *et seq.*, this Town Council of Sellersburg, Indiana (this "Council") is the town legislative body and the President of the town council is the town executive; and,

WHEREAS, pursuant to Ind. Code § 36-5-2-9, the legislative body may adopt ordinances and resolutions for the performance of functions of the town; and,

WHEREAS, from time to time, this Council desires to amend its previously adopted ordinances; and,

WHEREAS, this Council previously adopted *Ordinance No. 96-657 An Ordinance Creating a Schedule of Fees to be Assessed by the Town of Sellersburg Plan Commission and Board of Zoning*; and,

WHEREAS, this Council now desires to amend the fee structure set forth in *Ordinance*No. 96-657 An Ordinance Creating a Schedule of Fees to be Assessed by the Town of
Sellersburg Plan Commission and Board of Zoning.

NOW THEREFORE BE IT ORDAINED by this Town Council of Sellersburg, Indiana as follows:

- 1. The fee for filing an appeal to the Board of Zoning Appeals for a decision made by the Sellersburg Building Commissioner shall be \$250.00 per petition.
- The fee for filing a petition for a zoning variance shall be \$200.00 and for each additional request within the same application the fee shall be \$100.00 per request.

- 3. The fee for filing a petition with the Plan Commission shall be \$250.00 per petition.
- 4. The fee for the review of a development plan by the Sellersburg Building Commissioner shall be \$250.00.
- All fees shall be collected by the Sellersburg Building Commissioner prior to taking any action on said petitions.
- 6. This ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Council.
